In the G.O.1<sup>st</sup> read above, orders were issued, constituting a Tender Committee under the Chairmanship of Special Chief Secretary to Government, E.F.S. & T. Department and Members to finalize the modalities including Tender Document for the sale of 5376.043 MTs of Red Sanders wood to be conducted in phased manner, through global e-tender cum e-auction.

2. In the letter 3<sup>rd</sup> read above, the Vice Chairman & Managing Director, Andhra Pradesh Forest Development Corporation Limited, has requested to accord permission to conduct global e-tender cum e-auction in Phase-XXI for a quantity of 905.671 mt of Graded Red Sanders Wood of 'A', 'B' and 'C' grades in three cycles i.e., on 06.03.2025 (Thursday) in the 1<sup>st</sup> cycle and unsold lots on 13.03.2025 (Thursday) in the 2<sup>nd</sup> cycle and again on 20.03.2025 in the 3<sup>rd</sup> cycle for the unsold lots.

3. The Government, after careful examination of the proposal submitted by the Vice Chairman & Managing Director, Andhra Pradesh Forest Development Corporation Limited, hereby accord permission to conduct a global e-tender cum e-auction in Phase-XXI for a quantity of 905.671 mt of graded Red Sanders Wood of 'A', 'B' and 'C' grades in three cycles i.e., on 28.02.2025 (Friday) in the 1<sup>st</sup> cycle and unsold lots on 06.03.2025 (Thursday) in the 2<sup>nd</sup> cycle and again on 13.03.2025 (Thursday) in the 3<sup>rd</sup> cycle for the unsold lots.

4. The Principal Chief Conservator of Forests & Head of Forest Force, Andhra Pradesh and the Vice Chairman & Managing Director, Andhra Pradesh Forest Development Corporation Limited shall take further action in the matter accordingly.
