O R D E R:

The post of Deputy Conservator of Forests is constituted as Category -I, Class-A of Rule 2 of the Andhra Pradesh State Forest Service Rules. As per Rule 3 of the said Rules, the method of appointment to the post of Deputy Conservator of Forests is by promotion from the category of Assistant Conservator of Forests. As per the Indian Forest Service (Recruitment) Rules, 1966, "State Forest Service" means any such service in a State, being a service connected with the Forestry and the Members having Gazetted Status. The year-wise seniority lists of State Forest Service Officers i.e. Deputy Conservator of Forests were finalized upto the year 2022 in the G.O. 5th read above.

2. In letter 6th read above, the Principal Chief Conservator of Forests & HoFF, Andhra Pradesh, Mangalagiri has furnished the provisional seniority list of Deputy Conservator of Forests (SFS) as on 01.01.2023 and requested to finalise the same.

3. After careful consideration of the proposal of the Principal Chief Conservator of Forests & HoFF, Andhra Pradesh, Mangalagiri in the light of the provisions of Andhra Pradesh Forest Service Rules and Andhra Pradesh State and Subordinate Service Rules and also orders issued from time to time in the matter, Government have approved the provisional seniority list of Deputy Conservator of Forests (SFS) as on 01.01.2023 vide Memo. 7th read above and decided to communicate them to the concerned for making representations, if any, against the provisional seniority, before finalization. Further, the Principal Chief Conservator of Forests & HoFF, Andhra Pradesh, Mangalagiri was permitted to keep the provisional seniority lists in the Department website forthwith and the said communication shall be treated as deemed communication to all the officers concerned.
